Although the fortunes of the club have undoubtedly improved since the injection of new investment by Tom Wagner and his colleagues, I am still keen to ensure that the club develops robust and meaningful fan engagement strategies because that remains as important as it ever was. In my view, a football club run properly involves its supporters and listens to what is of interest and concern to them. A club is, after all, an association of interested parties. The Trust is ideally placed to represent the views of Blues fans and to seek to hold the club to account.

I am also anxious that genuine supporters across the game as a whole are being marginalised as international finance and corporate interests increasingly attach themselves to football in the UK. I don't want that to happen at the club I love and support. And I have become ever more concerned at the way professional football has developed in recent years. I am not at all convinced that the current model is sustainable, despite the staggering sums of money presently involved at the top of the tree.

of the club was a watershed moment. I wanted to give more active support to those trying to improve the situation. I was invited to join the Board of the Trust in March of 2015 and have been a Board member continuously since that time.

It has not been an easy journey either for the club or the Trust over that period. The struggles of the club are well-documented, those of the Trust less so. However, from almost going out of existence in 2015/16, I believe the Trust has subsequently become a respected and credible organisation both in the media, in the Football Supporters Association arena and, more recently, with the club. It bears repeating that the Blues Trust was one of the few Trusts selected to have a direct meeting with Tracey Crouch as part of the Fan Led Review. I am pleased to have played my part in making this happen.

I strongly believe that a football club belongs as much to its supporters as it does to its owners. Players, managers and financial owners are transient – fans are forever. Even though football has now become dominated by money and business interests, all supporters should still have the right to have a voice in the running of their club. Having said that I am encouraged by the recent takeover and the willingness of the new owners to engage with the supporters. Through the Trust, I will continue to work to try and bring this about. I will also seek to build the relationships with both the Club, other fan groups and the community, and work with them to seek solutions to issues which are important to supporters. I will continue to support the implementation of the Fan Led Review, the basic principles of which I have believed in for some time before they became formalised in the FLR document. Finally, I will continue to help the Trust to develop both in membership and its relevance to all supporters.
